7. PROPER CLOTHING AND FOOTWEAR FOR WEATHER CONDITIONS AND PROPER OPERATION OF THE VEHICLE.
8. STUDENT MUST OBTAIN A TEMPORARY INSTRUCTION PERMIT (TIP) AT HIS/HER OWN EXPENSE.
